In accordance with article 1, paragraph 1.3 (d) of regulation 2001/19 on the branch of executive, provisional institutions of self government of Kosovo.

According the provisions of article 2 paragraph 2.2, law of disability pensions, With purpose to evaluate and make a right verification of applicant's health condition of disability pensions, Permanent Secretary of Ministry of Labor and Social Welfare draw this:

ENGAGEMENT OF MEDICAL EXPERTS IN
MEDICAL COMMISSIONS OF MLSW**

Article 1

Purpose of administrative instruction

- 1.1.** With this administrative instruction in unique way regulate engagement on labor, criteria of engagement, working schedule and financial compensation of international doctors to evaluate and explore medical condition of applicant for disability pension.

Article 2

Engagement of medical experts

- 2.1** Ministry of Labor and Social Welfare, department of pension administration, with aim to enforce right and with effect DP law in Kosovo, will hire foreign experts on medical commissions of MLSW to examine applicants of this pension.

Article 3

Engagement criteria

- 3.1** Medical commissions of MLSW after examination and explore of applicant's health condition, should be made by:
Qualified specialists and witnessed on medical field, as from branch of labor medicine orthopedic, psychiatrist ect.

Article 4

Engagement forms

- 4.1** Medical commissions of MLSW after examination and explore of applicant's health condition for this pension, can be engaged with full working hours, half working schedule and timely according needs of MLSW, when it has to deal with flexible engagement way of medical commission work, when there is no need for full working schedule.
- 4.2** In case of medical commission engagement should apply provisions of Administrative Instruction no# MSHP/DASHC 2003/09 for working hrs.

Article 5

Financial compensation

- 5.1** Medical experts engaged on medical commissions of MLSW in full working schedule and half working schedule will be compensated as the other civil servants of Kosovo. Medical experts engaged on medical commissions of MLSW time after time flexible schedule of work, for daily participation will be compensated 30-40€
- Specialists 30€
 - Magistrate 35€
 - Doctorate 40€
- 5.2** Medical commission with in a working day, at least should evaluate 25 applications of claimants for DP.

Article 6

For medical personnel

- 6.1** For medical personnel of DKPA engaged as a head of commission for a participation out of working schedule is allowed to get financial compensation 30 €per day.
- 6.2** Workers of DKPA engaged with medical commissions out of regular working schedule is allowed to get 15 €per day.

Article 7

- 7.1** This Administrative will enter in force, on the day signed by Permanent Secretary.
