According to article 1 point ç of Regulation No.2001/19, on Executive Branch of Kosova Provisional Institutions of Self Government.

In view of Annex VII point (IV) of Regulation No.2001/19 on Executive Branch of Kosova Provisional Institutions of Self Government.

With purpose to provide regulations and unique standards for presentation and introduction of disability persons and underage in informative media, Minister of MLSW legislates this:

**ADMINISTRATIVE INSTRUCTION NO 2/2003
ON
PRESENTATION OF DISABILITY PERSONS AND
UNDERAGE IN INFORMATIVE MEDIA**

Article 1

Purpose of the administrative instruction

- 1.1** These Administrative Instruction determinate forms, conditions, procedures of presentation in informative media of abandoned baby's, disability persons and underage, they are under observation and attention of legal protector and professional institutions of MLSW.

Article 2

Responsible institutions of MLSW

- 2.1** According to the applied Law in Kosova as responsible institutions for care of abandoned baby's and disability persons are Centers for Social Work, who work and operate in all municipalities of Kosova.
- 2.2** Institution Division and Social Service Division of DSW, according to juridical regulations observed and protect identities and privacy of abandoned baby's and disability persons, considering ethnic and professional standards, according to Internationals Conventions for child protection and human right.

Article 3

Obligations of other care institutions

- 3.1** Hospitals, Governmental Organization (GO), Non-Governmental Organization (NGO), and other institutions that cares for abandoned baby's, children's and disability persons are obligated to respect and protect identities and privacy of those persons, not to expose those persons on informative media, if apropos opportunity liable for them like family unification, housing in receiver family, adoptive family and moral or spiritual rehabilitation in there community.

Article 4

Presentation procedures in informative media

- 4.1** Presentation of abandoned baby's, children and disability persons in informative media who are under protection, is needed preliminary accord of legal protector.
- 4.2** For above mention persons who are resident of hospitals, collective houses, or in residential care, for presentation is needed decision of Institution Division and Social Services Division of DSW, approved by Informative office of MLSW.

Article 5

Forms and condition of presentation in informative media

5.1 Presentation and showing in media of above mention persons may be done through text, photos and films, under these conditions:

- **Presentation through text:**

Is not allowed to use name and other private information's, preliminary accord of legal protector, competent Division of MLSW must be provided.

- **Presentation through photos:**

Is allowed only from profile and from behind, preliminary accord of legal protector-competent Division of MLSW must be provided.

- **Presentation through film:**

Is allowed the film for 2-3 sec. provided that, to not identify identity of person, preliminary accord of legal protector –competent Division of MLSW must be provided.

Article 6

Enter in force

This Administrative Instruction will enter in force on the day signed by Minister of MLSW.
