# ON AMENDMENT AND SUPPLEMENTATION OF THE LAW ON LABOUR INSPECTORATE NO. 2002/9

# The Assembly of the Republic of Kosovo,

In accordance with Regulation No. 2001/9 date 25<sup>th</sup> May for Constitutional Framework on Provisional Self Government in Kosovo;

Based on UNMIK Regulation No. 2001/27 on Fundamental Labour Law in Kosovo;

Having into consideration the need of establishing Labour Inspectorate as an important mechanism that supervises implementation of Labor Law and protection provisions at work

With a purpose of avoiding obstacles and difficulties in implementation of the Law on Labour Inspectorate,

Approves:

# LAW ON AMENDMENT AND SUPPLEMENTATION OF THE LAW ON LABOUR INSPECTORATE NO. 2002/9

## **Article 1**

In Article 1 paragraph 1, in the title of Article 3 and in paragraphs 1, 2, 3 of this Article, in Article 4 paragraph 1, 5, and 6 and in Article 6 paragraphs 1 and 2 words "Labour Inspectorate Authority" are replaced by words "Labour Inspectorate".

#### Article 2

Article 1 paragraph 1 is reworded as following:

"With this law is established Labour Inspectorate as an Executive Agency of the Ministry of Labour and Social Welfare. Labour Inspectorate oversees implementation of legal and sub-legal provisions, in overall manner of employment field including employment relationships, safety at work, protection of employees' health and work environment",

In paragraph 2 of Article 1 second line the following word is deleted "and non governmental",

#### **Article 3**

Text in point "a" of Article 2 "working conditions and protection at work" is replaced with the text "Law on Safety at Work, Protection of Employees' Health and Work Environment, and also other applicable provisions from the field of employment and protection at work".

## **Article 4**

Article 3 paragraph 1 is reworded as following:

"Labour Inspectorate is established by Ministry of Labour and Social Welfare and is responsible to this Ministry in relation to the coordination of executive actions regarding the Labour Inspectorate in Kosovo".

In Article 3 a new paragraph is added with the following text and content:

3.3 "Labour Inspectorate is comprised of Chief in Charge of Labour Inspectorate and Labour Inspectors who exercise their function in the entire Republic of Kosovo territory".

Paragraph 3 of Article 3 is transferred to Paragraph 4 of Article 3 and instead of words "tax inspections, health inspections "is written "inspectorates".

### **Article 5**

In point (c), paragraph 2 of Article 5 after the word "labour" is added the text: Law on Safety at Work, Protection of Employees' Health and Work Environment and other applicable provisions.

In point (c) paragraph 5 of Article 5 is reworded as following "write down in an official report, incompliance or violence of legal provisions. Labour Inspector enunciates the fine with decision".

In point (d) in second line of paragraph 5 of Article 5 instead of the word "production" is written "work" and after the word "employees" is added the text "and third persons and also in cases when employer does not posses work license".

Article 5 paragraph 9 is reworded as following:

"Labour inspectors in case of inspection shall have with them the applicable laws on employment relationship and safety at work. Official act which is issued by Labour Inspector shall be drafted in one of official languages in Kosovo".

#### Article 6

In the first line of paragraph 1 of Article 6 after the word "work" are added "first expertise organ" while in the second line of paragraph 1 of Article 6 after the word "work" is added the text "second expertise organ".

#### Article 7

In Article 9 after the word "power" is added the text: "after adoption by Kosovo Assembly and the on the day of promulgation by United Nations Special Representative of Secretary General".
