The Prime Minister of Kosova's Government

In accordance with responsibilities and authorizations of the third section, indent 9.3.1 of Constitutional Framework for Provisional Self-Governance in Kosova, which was enforced with UNMIK Regulation No. 2001/9,

Based on Article 58 of the regulation on work of Kosova's Government,

With a purpose of ensuring financial payments, in the form of pensions to the most damaged categories, because of the armed war in Kosova, issues this:

**ADMINISTRATIVE INSTRUCTION NO. 01-/2007  
ON THE  
RULES AND PROCEDURES FOR IMPLEMENTATION OF THE LAW NO. 02/L-2 ON THE STATUS  
AND THE RIGHTS OF MARTYRS' FAMILIES, INVALIDS, VETERANS AND KLA MEMBERS AND  
FAMILIES OF WAR CIVIL VICTIMS**

**Article 1**

**The purpose of Administrative Instruction**

With this Administrative Instruction, are determined rules and basic procedures for partially implementation of Law No. 02/L-2 on the status and the rights of martyrs' families, invalids, veterans and KLA members and families of war civil victims, since 01.01.2007.

**Article 2**  
Scope of Administrative Instruction

This Administrative Instruction shall be implemented for the rights on financial payments in the form of pensions and different benefits without direct budget implications for the Nation martyrs' families and KLA war invalids with invalid level determined by Law.

**Article 3**  
Applicable provisions of Law

(1) From 01.01.2007 only provisions of Article 4 of the above-mentioned Law, which determine and enable financial help in the form of pensions, for National martyrs' families and KLA war invalids.

(2) Favor of these two categories for utilization of financial payments in the form of pensions, compared to other categories of KLA war, is made due to their high contribution and sacrifice in war and having into consideration the very difficult material.

(3) Partial implementation of provisions of Article 4 of the Law which determine and enable the rights on pensions and different benefits, for the categories included in the Law, is made due to lack of budgetary means for entire implementation of the Law.

**Article 4**  
Special benefits

Martyrs' families and KLA war invalids, except financial payments in the form of pensions, from 01.01.2007, may acquire also some special benefits determined by the above-mentioned Law, which do not have direct budgetary implications.

**Article 5**  
Financial payments in the form of pensions for other categories included in the Law

Other categories included in Law (families of civil victims, war civil invalids and families of missing persons during the war), until the entire implementation of the Law, will realize their rights to financial payments in accordance with provisions of Regulation No. 2000/66 on benefits of war invalids of Kosova and their next of kin who have died as a cause of armed conflict in Kosova.

## **Article 6**

### **Engagements for entire implementation of the Law**

Kosova's Government respectively Ministry of Labour and Social Welfare, through budgetary reviews will make effort to create conditions for Law in question to start entire implementation from 01.07.2007

## **Article 7**

### **Implementation procedures of Administrative Instruction**

Realization of the rights to financial payments in the form of pensions for martyrs' families and KLA war invalids, and other rights and obligations, which do not interconnect with budgetary implications, will be in accordance with determined procedures with Law and sub legal acts issued by Ministry of Labour and Social Welfare and other Ministries with competency of Kosova's Government.

## **Article 8**

### **Implementation of Administrative Instruction**

For a proper and efficient implementation of Administrative Instruction will take care the Ministry of Labour and Social Welfare respectively Department of martyrs' families and war invalids of this Ministry.

## **Article 9**

### **Entry into force**

These Administrative Instruction enters into force after signature of Prime Minister of Kosova Government, while shall be implemented from the date 01.01.2007.
