DETERMINATION OF FINANCIAL PAYMENT IN DAILY PAY FORM FOR
MEMBERS OF COUNCIL FOR SOCIAL AND FAMILY SERVICES

Article 1

Purpose of this Administrative Instruction

Through this Administrative Instruction are determined rules and procedures of financier payments in daily pay form for the members of Council for Social and Family Services.

Article 2

Destination of financier payments

Monthly financier payments in daily pay form for members of Council for Social and Family Services shall be made with a purpose to approaching and engagement committed

to permanent members of the Council, in realization of duties and responsibilities determined by Law on social and family services and with other sub-legal acts.

Article 3

Level of financial payments

In the mandate of exercising the function as President, deputy President and members of Council, amount of financial payments for a month in daily pay form shall be as follows:

- For President of Council for Social and Family Services.....80 Euro
- For Deputy President of Council for Social and Family Services.....70 Euro
- For other members of Council for Social and Family Services.....50 Euro

Article 4

Forms of Daily Pay Compensation

Monthly financial payments in the form of daily pay, shall be acquired by members of the Council in retroactive form, from 01.07.2006, which date is related to establishment of Council for Social and Family services.

Article 5

Cut off in financial payments

For non participation in the session of the Council, members who miss shall be cut off the financial payment of daily pay for the corresponding month, during which the meeting of Council was held.

Article 6

Sources of financial means payments

Monthly payments for members of Council shall be paid from financial means of Department of Social Welfare of Ministry of Labour and Social Welfare.

Article 7

Implementation of Administrative Instruction

For proper and efficient implementation of this Administrative Instruction takes care the executive-financial Director of Ministry of Labour and Social Welfare

Article 8

Entry into force of Administrative Instruction

This Administrative Instruction shall enter into force the day of signature by Minister of Ministry of Labour and Social Welfare from 01.07.2006
