According to the Regulation No.2001/19, article 1.3, point ç on Executive Branch of Kosovo Provisional Institution of Self-Government, with purpose to norm the work and to design conditions and standards of resident placement in Institution of old persons and without family care, Minister of MLSW legislate this:

**ADMINISTRATIVE INSTRUCTION No.11/2004**  
**ON**  
**WORK AND STANDARDS OF RESIDENTS**  
**PLACEMENT IN HOME FOR OLD AGE PERSONS**  
**AND WITHOUT FAMILY CARE**

**Article 1**

**Purpose of this administrative instruction**

- 1.1** This Administrative Instruction regulates work of Home for old age persons and without family care, also the condition and standards for resident's placement in this Institution.

**Article 2**

**Denomination change of the institution**

- 2.1** With this Administrative Instruction change denomination of this Institution from: Home for elders and disability persons in to: "HOME FOR OLD AGE PERSONS AND WITHOUT FAMILY CARE".
- 2.2** With change of name of this Institution, will be also change of stamps and other identification logos of this Institution.

**2.3** The ax of this Institutions name will be HOPWFC (SHPMPF).

### **Article 3**

#### **Activity of hopwfc**

- 3.1** Primary activity of HOPWFC is taking care for old persons who are without family care
- 3.2** HOPWFC is an institution of social character and work in frame of Ministry of Labor and Social Welfare.
- 3.3** Work and activity of HOPWEC is supervised and controlled by Institution Division of MLSW.
- 3.4** With work of HOPWEC lead Director of HOPWEC.

### **Article 4**

#### **Services of hopwec**

- 4.1** HOPWEC for residents offer 24 ours services:
  - A. Feeding
  - B. Clothes
  - C. Health care
  - D. Work therapy

### **Article 5**

#### **Placement basic standards**

- 5.1** To won the placement right in HOPWEC applicant must fulfill those basic standards:
  - Must be permanent resident of Kosova
  - To have 65 years
  - To be without family care
  - To be in good mental condition

- To not have infection illness

## **Article 6**

### **Necessary documents for placement in hopwec**

- 6.1** For institutional housing in HOPWEC, applicant file must be completed with those documents:
- a.** ID- card
  - b.** Metrics
  - c.** Specialist doctor (Infectolog) certificate
  - d.** Specialist doctor (Neropsiciater) certificate
  - e.** Economic situation certificate
  - f.** Family situation certificate
  - g.** Two photo

## **Article 7**

### **Documents review commission**

- 7.1** Commission of resident admission is composed by the representatives of Institutions Division and high officers of HOPWEC.
- 7.2** Institutions Division as regarding to offer request from CSW regarding resident's placement, when they estimate may do the verification of data in links.
- 7.3** After the verification of links situation in consult with Commission, Institution Division of DSW, take a decision for placement residence in HOPWEC.
- 7.4** Decision take valid form of execution after the Director DSW sign, and for that must be informed CSW of respective Commune.
- 7.5** Work procedures regarding request of applicant for Institutional housing must be fulfillment within 30 days.

## **Article 8**

### **Writing agreement between hopwec and csw**

- 8.1** When is done the resident placement, HOPWEC and CSW make a Collaboration Agreement regarding reciprocal obligations for placed resident in HOPWEC.
- 8.2** With agreement must be fixed date and duty which must be finished by the CSW.
- 8.3** For authentic implementation of this instruction with recommendations of Minister or Permanent Secretary of MLSW, Director of DSW can take respective decision.

## **Article 9**

### **Enter in force**

- 9.1** This Administrative Instruction will enter in force from the day when is signed by Minister of Ministry of Labor and Social Welfare.
