**PROPOSAL NR. 04/2005**

**FOR CHANGES AND ADDITIONS OF THE ADMINISTRATIVE GUIDELINE NR.  
16/2004 FOR REGULATION OF FAMILY SHELTER IN KOSOVO**

**Article 1**

**1.1.** Paragraph 6.1 of article 6 is changed and completed in a way that amount of 90€be exchanged with amount of 100€

**1.2.** Paragraph 6.3 of article 6 is conveyed on paragraph 6.5 of the same article and is changed on the last paragraph and will have this content: depending on the budget possibilities and other circumstances the amount of monthly payments might be changed with the decision of MLSW.

- 1.3.** New paragraph 6.3 has been added to article 6 by this content: beneficial right, according to these changes and additions of this Administrative Guideline, will have those children who do not benefit from other regular schemas of social welfare and managed by MLSW.
- 1.4.** Paragraph 6.4 of article 6 is changed and is fully completed. New paragraph 6.4 will have this content: For children who are parentless and with no existential funds, under the care of guardian and in accommodation of their relatives will be paid in amount of 50€ for one child.

## **Article 2**

- 2.1.** To the article 7 of Administrative Guideline is added paragraph 7.3 with this content: Centers for Social Work must make a written contract with family which offer shelter, because of a higher legal security and for setting up the duties and responsibilities

## **Article 3**

- 3.1.** Proposal nr. 04/2005 for changes and additions of Administrative Guideline nr. 16/2004 for setting up a Family Accommodation in Kosovo enters in power after being signed by the Minister of MLSWE, whereas it will be applied from 01.01.2005.
