In accordance with the Regulation 2001/9, Article 1.3, point (ç) on the Executive Branch of Provisional Institutions of Self-Government,
By taking under consideration the Article 4.9 of the Law 2003/23 on Pensions of Disabled Persons in Kosova,
With a purpose of offering the opportunity to reapply for disability pensions of potential seekers, Ministry of Labour and Social Welfare issues this:

**PROPOSAL NR.9/2005
FOR
MODIFICATIONS AND SUPPLEMENTS OF ADMINISTRATIVE
INSTRUCTION NR.09/2004 ON PROCEDURES FOR MAKING A
REQUIREMENT FOR DISABILITY PENSION**

Article 1

- 1.1** After the Article 7 of the Administrative Instruction Nr. 9/2004, is added the Article 8 with a title "Reapplying procedures" that will have this content.
- 1.2** Every applicant for disability pension whose requirement was rejected from corresponding authorities, in accordance with conditions and criteria determined by Law on Disability Pensions and other sub legal acts has a right to reapply for this pension.
- 1.3** Reapplying for disability pension, can be done from applicant only after a year from the day the request for disability pension was made.
- 1.4** In the specific cases the applicant for disability pension, can reapply also before a year from the day the request was made, but not early than six (6) months from the day of the request for disability pension.

1.5 Reapplying for disability pension after six (6) months, from the day the request, can be done when we have to do with illness with quick development that damage health and decrease working ability.

1.6 Illness with quick development, that damage health and decrease very much working ability according to Medical Commission of MLSW are:

- Carcinoma of all organs evidenced with histopathology examination,
- Cerebral vascular insult
- Status post infractus myocardi,
- Insufficiency of terminal renal
- Homeopathies
- Poly traumas (during accidents, extremes' amputation)
- Epilepsy with frequent crises,
- Hard psychoses
- Decompensate hepatic cirrhosis
- Rheumatoid Arthritis gr. III-iv,
- Morbus Perthes
- Post traumatic eye damages and other illness of eye that damages hardly the ability to see,
- And other illness that hardly damage health.

Article 2

2.1 Article 8 of Administrative Instruction Nr. 09/2004 on Procedure of Making Requirement for Disability Pension becomes **Article 9**.

Article 3

3.1 The proposal Nr. 09/2005 on modification and supplement of Administrative Instruction Nr. 9/2004, enter into force after endorsement of Minister of MLSW, while it will be implemented from **01.07.2005**.
